How do I leave a gift in my will to Katharine House Hospice?

Leaving a gift in your will to Katharine House Hospice could not be simpler. If you haven't yet made a will, then it can be done when you see your solicitor. If you already have a will your solicitor can simply add a codicil (an addition to it) specifying Katharine House Hospice.
